Sub : Non cooperation / disruption of freedom of Indian citizens in Amrapali Village by Amrapali Village maintenance team to celebrate Holi by AV residents - reg:

Dear Sir,

Amrapali Village residents along with AVRWA decided to celebrate Holi on 23 & 24th March 2016 which was duly informed to Amrapali Group management vide letter reference **AVRWA/15-16/L52 dated 29-02-2016** and requested the support of the maintenance team (which is under Amrapali Group) for the proper arrangements.

Many of the residents are complaining that maintenance team (Mr.Pratap Rai & Mr.Manish) is not cooperating and it is clearly evident that they are planning to disrupt the Holi function similar to the last year incidents reported to Mr.Anil Kumar Sharma (CMD, Amrapali Group) vide letter reference **AVRWA/14-15/L09 dated 07-03-2015** (Breaking the locks of notice board to disrupt Holi 2015 celebration - Police was called to protect the residents against miscreants who were covering the face and created an havoc), letter reference **AVRWA/14-15/L07 dated 21-02-2015** (Republic Day 2015 celebrations disruptions by Mr.Anjani Rai & maintenance team). Few of the past correspondence letters are enclosed for your kind reference.

We are worried with the behavior of AV maintenance team and several times it has been highlighted to the Amrapali Group management, but no action till now. Now it has come to our notice that, the maintenance team along with few anti social elements, planning to disrupt the Holi celebrations by all possible ways. We came to know that they may block the spaces or organize separate celebrations and we are very much afraid that it may end up in any communal clash or so. As a responsible legal abiding citizen, we thought of bringing this matter to your immediate notice and request you to take necessary action.
