Sub: Prior information regarding the mass peaceful protest at Amrapali Corporate Office, Sector-62, Noida on 12<sup>th</sup> September 2015 (10:30 to 11:00 AM) by the residents of Amrapali Village, Indirapuram (Ghaziabad) - reg:

Sir,

This is to inform your good office that we are the responsible citizens of this country and residing in "Amrapali Village" residential society situated near Kaala Pathar, Indirapuram. The residents are facing a lot of problems in our society related to Security, welfare, health hazard and undisciplined staffs in the maintenance office, which is still being run by the builder (Amrapali Group) itself.

The issues were discussed number of times between AVRWA and Amrapali Group builder but no pain have been shown by the builder to resolve these issues. In the last meeting held with the AVRWA on 30-5-2015 on an open forum along with hundreds of residents, the builder had discussed the following pending issues and assured of addressing the same which is kept pending till date.

- (I) Garbage yard beside our society wall.
- (II) Ganga water connection.
- (III) Fire fighting arrangements in new blocks.
- (IV) Pending mock drill of fire equipments in all the blocks.
- (V) Power backup arrangement for new blocks.
- (VI) Poor Security arrangements in the society,
- (VII) Construction of play area near new blocks.
- (VIII) Worse Lift maintenance etc.

After the brief meeting with the residents, the builder agreed to sort out these issues on priority basis. But it is regret to say that no attention has so far been given in resolving the issues. Rather the situation has become much worse and painful. Now, the behaviour of the maintenance & other staffs towards the residents has become more indecent and indiscipline and threatening too. The builder was informed many times regarding the same but no action has been taken. Ten days ago, maintenance staffs had badly abused the residents and threatened them to disconnect the existing water & electricity connection.

The builder was informed the matter vide email dated 30.8.2015 and request to remove the indiscipline staffs from our society for their act towards the residents. It was found that these people were working with the society miscreants and disturbing the harmony of the society. We have also requested the builder to give a proper attention on other pending issues but till date no action has been taken by the builder.

Now the situation became intolerable and the residents are left with no option but to take resort to a peaceful demonstration before the builder to sort out the issues. As such, we, the residents of society have decided to mark our protest on our unresolved issues and it is proposed that the residents will like to assemble at
