**Sub: Serious security lapses in Amrapali Village society - reg:**

Dear Sir,

With due respect, we would like to draw your kind attention towards the serious security lapses in our society. During the meeting held with the residents and AVRWA after the fire incidence in the society, it was informed by the security agency owner (Mr. Jaswant Chauhan) that Amrapali Group has made a contract agreement with them to provide and deploy 45 numbers of security guards for the residents safety.

Mr. Jaswant had however intimated to the residents that the number of guards are insufficient to guard this much big society and on security (safety) point of view, at least 60 security guards are required. The residents had requested the agency supervisor to provide a copy of the agreement. But they have not provided the copy of the agreement to AVRWA till date.

Now, this is to inform you that the situation has gone worse. The residents of the society made a complaint on 3.12.2015 night shift, no security guard was available at main gate. The main gate was open at midnight and only one guard was sleeping inside the cabin. When he was asked about the reason, he stated that he was doing duty continuously for 36 hrs and there is a shortage of guards. We, along with few residents of the society verified the attendance register on 5.12.2015 and it was observed that only 11 guards were on duty on that very night instead of 22.

It was also observed that this is not the concern of one day or one shift, but there are always 25 to 28 guards only instead of agreed 45 to 46 guards, come for duty on routine basis. The matter has been viewed seriously by the residents and they want a clarification in the matter with the security agency.

In view of above, you are requested to look into the matter and the security agency may be asked to provide us the below listings.
