Sub: Status of Ganga Water connection

Dear Ajay ji,

Refer to your meeting along with Mr.Mohit Gupta on 30-05-2015 at 06:30 pm held in G block Club with the AV residents & AVRWA to discuss on various pending issues. One of the main issue was "Ganga Water connection" which was not provided to us. You have promised to the AV residents for the Ganga water connection to pay Rs.1140.00 including service tax and the facility will be provided within 15 days time.

Mr.Anjani Rai who was present in the meeting assured to you in front of the AV residents that the Ganga water connection shall be done in 15 days time from the date of receipt of Rs.1140.00 payment.

Followed by the meeting, AVRWA issued a circular notice (Ref: AVRWA/15-16/L01 dated 02-06-2015) to all the residents about the payment of Rs.1140.00 which shall be deducted along with the June 2015 maintenance bill under the sub heading "Water Charge".

Amrapali Maintenance & Support also issued the circular (Ref No: AMS/MAINT/15-16/017 dated 01-06-2015) to AV residents stating that Rs.1140.00 (Rs.1000.00 + Service Tax Rs.140.00) per flat will be deducted in June 2015 prepaid electricity bill towards Ganga water connection and the same amount shall be contributed by Amrapali Group also to get the work done on time.

It's been more than 2 months and no Ganga water connection and no response from your end. Residents are getting angry over AVRWA also that how we believed the promise of Amrapali Group and supported for deducting the money.

Today couple of residents went to ask for the status of Ganga water connection, maintenance people Pratap, Bubbli along with Mr.Manish Kumar Singh (General Secretary, AVNRWA) abused them with bad words and threatened with disconnecting the existing water connection & electricity connection.


