As you would be aware that two Air circuit Breakers of Electric panel in our Amrapali Billage Residential society, Indirapuram was got damaged on 8th August 2016 afternoon and we requested vide email dated 9.8.2016 to send a team immediately to ensure repair/replace the ACBs. On 11.8.2016, we received a reply from Mr. N.N.Singh, AVP that he will depute a team to society to instant resolve the issues. As the problem was not resolved, we again requested CEO (facilities management) on 16.8.2016 to see the matter on urgent basis and resolve the same. In response, we got a reply that the matter has been noted and team on the job. We became satisfied with the reply and thought that it will be rectified soon.

But on 24.8.2016, when we were informed that the problem has been resolved, we went to verify the content near Panel room of the society, I became shocked to see the status of panel. The two damaged ACB were out from the panel box and remain as usual situation. When we enquired for it from the technician, it was informed that those were the damaged ACB and yet to be repaired. We immediately informed the situation and status of panel vide email dated 25.8.2016 to your officials and again requested to visit this issue on urgent basis and issue necessary approval to rectify the problem in the interest of the residents of society could not be suffered. But, no one is able to hear the pain of the residents and situation is same. Copies of all email were sent already to you for perusal.

Now, we have no option remain to urge directly to you to visit the issue on your own level and instruct the concerned authority to resolve the problems.

Dear sir,

Good morning.

This is for your information that yesterday the residents of Amrapali Village Society became much anxious on the attitude shown by your maintenance staffs.

In afternoon, the light of whole society went off. When residents tried to contact maintenance office, it was found that the intercom was not functioning. The Direct telephone number was also not responding by anyone. When the matter was inquired by residents from the Maintenance team, they were unable to tell about the problems.

When residents contacted electrical team, they told that the Air circuit Breaker -1250 Amps contact points which is used in Draw-in Draw-out panels has aged down and the contact points were not intact and it failed. The electrician tried some to do some make up and refitted. Suddenly, it generated arcs and tripped. He removed the ACB and used the standby breakers. Now 2 nos of ACB are faulty and waiting for the repair for which the payment was not being cleared. He further told that Point of contact damaged and it may create continuous arc and if ignored, it may end up in electrical fire. We residents continuously facing problem of tripping of light and due to over voltage and voltage fluctuations, the electric and electronic appliances of many residents have got damaged.

The residents of society is in much anger. when we are paying every month maintenance charges then why the Company is continuously ignoring all the problems in the society? Why the management is trying to hold the payment of our vendors? without money, how they will work? All the items installed in society need replacement now because perhaps it completed its life. The radius team has also been informed in this regard.

Please look into the matter and send a team from your organisation and specially Mr. N.N. Singh, who is looking after the electric related issues immediately to the site and ensure an immediate solution of the problem related to panel and DG of the society. Earlier, on many occasions, we informed you about the problems related to electrical problems of the society but in vain. Please also look the telephone systems which always become fail when light goes off.

Please look into the situation. An early action is solicited. Otherwise, if any major problem occurs, the management will be sole responsible for the same.
