Eligibility Criteria

All Registered Flat Owners in Amrapali Village Residential society are entitled to participate in the election process including voting. Those who have not enrolled as a member of association so far, can do so by depositing duly filled membership form along with the admission fee of Rs. 500/- only in cash (as decided in General Body Meeting dated 26.1.2016) with Mr. B. B. Bhat, Mr. Maheshwaran Nair or Mr. Vivek Sharma. The name of new enrolled members will be included in the voter list till **6 PM on 30th April 2016**. Only one voter per flat will be eligible to cast vote /contest election. Contestant/Voter must produce proof of flat ownership by means of producing self-attested photocopy of first and last two pages (back to back) of registered sale deed and one of the following as photo ID proof (Passport/Voter ID card/Driving License/Aadhar Card/PAN Card). Proxy voting is allowed on production of authority letter duly signed by the first owner on a non-judicial stamp paper of Rs 10/- in addition to the flat sales deed and photo ID proof as mentioned above.
